OUR MISSION IS TO CHANGE THE TRAJECTORY OF OUR STUDENTS' LIVES THROUGH ACCESS TO EXCELLENT EDUCATIONAL OPPORTUNITIES. WE PROVIDE AN EXTRA 14 MONTHS OF FULL-TIME SCHOOL FOR PROMISING AND MOTIVATED URBAN STUDENTS WHO HAVE COMPLETED THE 8TH GRADE, BUT WHO ARE UNDERPREPARED FOR CHALLENGING INDEPENDENT HIGH SCHOOLS.
